Just a place where your presence **isn't questioned.**

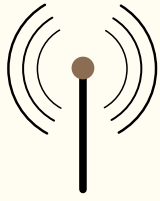


Infrastructure Quality

If your priorities are:

Lower cost + safety + infrastructure → look at parts of Latin America, Southern Europe, and mid-tier Asian hubs.

If your priorities are:

Stability + identity safety → look for countries where your demographic feels socially visible rather than scrutinized.

You're **not** looking for “perfect.”

You're looking for “supportive.”
